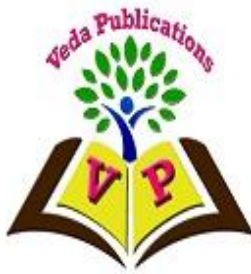
THE ENGLISH LANGUAGE IN THE GULF: A LINGUA FRANCA REDEFINING IDENTITY AND OPPORTUNITY
